The respondent notes that the ability to reach green spaces depends on the individual characteristics of a disabled person, their general health condition, and whether they have an assistant. The respondent notes that introducing guide strips for the blind in public places, including green spaces, and disability-friendly surfaces is a good solution. New technologies, such as QR codes in parks, can be used to indicate directions and provide accessible information. She mentions aspects related to surfaces, adapted benches, curb height, appropriate signage, surfaces and equipment in playgrounds and outdoor gyms. The respondent emphasizes that implementing solutions in green spaces is difficult due to environmental factors, which sometimes conflict with solutions that promote accessibility, such as creating appropriate surfaces without negatively impacting tree stands (primarily roots).
